RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASST. PROFESSORS IN SHRI JAGANNATH MEDICAL COLLEGE, PURI.

Eligible candidates are invited to attend the Walk in Interview for the post of Assistant Professors in Shri Jagannath Medical College, Puri on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis. The candidates who are already working as Assistant Professor/ SR/ Tutor or JR in any of the Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack, either on contractual /deputation or regular basis are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

1. AVAIALABLE VACANCY

The provisional vacancy will be notified in the website of DMET, Odisha i.e. www.dmetodisha.gov.in .

2. ELIGIBILITY:

2.1 The candidate must be a citizen of India.

2.2. Qualification:

2.2.1 The candidate must possess MD/MS/DNB or equivalent degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the MCI/NMC and as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI/NMC, in force, in conformity with OMES Rules 2013. The candidates having three years of post PG (broad specialty) teaching experience as SR/Tutor/Registrar & Demonstrator from any permitted/approved/recognized institute by MCI / NMC shall be preferred to candidates with one year post PG (broad specialty) experience. Further, the Candidates having MSc (medical subjects) in Anatomy, Physiology and Biochemistry subjects will be considered

if sufficient candidates with PG degree/ DNB are not available and subject to the limitations as may be prescribed by MCI/ NMC from time to time.

2.2.3 Must have registered himself/ herself under any State Medical Council/ MCI /NMC after obtaining the degree.

2.2.4 The above qualifications must have been obtained on or before the date of counseling/ interview.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Eligible candidates shall appear personally before the Convener in the Counselling Centre as per schedule (notified in website) and submit the application form attached to this advertisement duly filled in and self attested photocopy of required documents and color passport photograph during the walk in interview. They must bring all original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot which will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other information required, shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS. One mark will be deducted for each extra chance taken.

In case of candidates passed from foreign Universities, 60% of total percentage of marks secured in NBE shall be considered.

Engagement will be on the basis of merit. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. www.dmetodisha.gov.in. The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

6. TERMS AND CONDITIONS & SALARY ETC

All the terms and conditions as per Govt. letter No. 6547/H Dt. 4.3.2017 & Resolution No.5202/H. Dt. 26.02.2019, shall be applicable.

- a. The Contractual employees are entitled for remuneration of Rs. 75,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed usual salary and any incentive as may be notified by Govt.
- c. The engagement shall be purely temporary and on year to year tenure basis and may be for a period of four years subject to satisfactory performance. However, Govt. reserves the right to terminate the services of the faculty with one month prior notice from either side.
- d. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
- e. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
